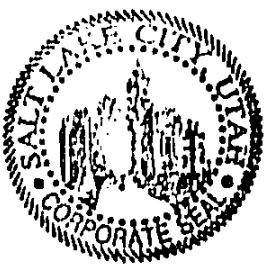

SALT LAKE CITY ORDINANCE
No. 74 of 1996
(Renaming a portion of 200 South to Pierpont Avenue
pursuant to Petition No. 400-96-23)

AN AMENDMENT TO THE OFFICIAL STREET MAP ADOPTED BY
SECTION 14.08.010, SALT LAKE CITY CODE, RENAMING A PORTION
OF A FRONTAGE ROAD COMMONLY KNOWN AS 200 SOUTH TO PIERPONT
AVENUE PURSUANT TO PETITION NO. 400-96-23.

WHEREAS, in response to Petition No. 400-96-23, the
City has determined that it would be in the best interests
of the City to rename a portion of the frontage road
commonly known as 200 South Street, more particularly
described below, to Pierpont Avenue;

THEREFORE, the City Council of Salt Lake City, Utah
hereby adopts the following amendment to the official Street
Map adopted by Section 14.08.010 of the Salt Lake City Code.

Be it ordained by the City Council of Salt Lake City,

Utah:

SECTION 1. That the official Street Map, as adopted by
Section 14.08.010 of the Salt Lake City Code, be, and the
same hereby is, AMENDED to change the legal name of the
portion of the frontage road commonly known as 200 South

Street, more particularly described below, to Pierpont Avenue.

The Portion of the street to be renamed is more particularly described as follows:

That portion of the street commonly known as 200 South Street, running from 1100 West Street to 1200 West Street, continuing on Concord Street to Navajo Street, and from 1400 West Street to Pueblo Street, parallel to Interstate 80.


SECTION 2. EFFECTIVE DATE. This ordinance shall become effective upon the date of its first publication and shall be recorded with the Salt Lake County Recorder.
