## EASEMENT AGREEMENT

The undersigned Grantor, for good and valuable consideration hereby grants and conveys to Ogden City, a Utah Municipal Corporation, a permanent and perpetual easement for the installation, repair, replacement, operation and maintenance of public utility service lines and facilities, as authorized by the Grantee, over, across and under the real property of Grantor described in Exhibit A attached hereto and incorporated herein by reference.

Grantee, its officers, agents, employees, and assigns, shall have the right of ingress and egress over and across the land of the Grantor to and from the above described permanent easement and all rights reasonably necessary or incident to the grant of said easement.

Grantor shall, subject to Grantee's rights contained herein, have the right to fully enjoy and use the premises for all purposes not inconsistent with this grant and not unreasonably interfering with exercise of the rights hereby granted.

After the initial installation, in the event of any repair, replacement, inspection or maintenance work, Grantee shall restore the surface of the ground to the same condition in which it was before the start of such work, as near as such restoration can be made.

All rights, title and privileges herein granted shall run with the land and shall be binding upon and inure to the benefit of the parties, and their successors in interest.

Ogden Plat 10 will share in the costs of maintaining and repairing the Joint Driveway Easement between said lots 19 and 22 equally. The responsibility of the actual maintenance and repair of such Joint Driveway Easement area shall be accomplished by the owner of Lot 22, and the three owners shall pay their respective shares of such maintenance and repair costs within thirty (30) days after billing therefore, such billing to be accompanied by reasonable supporting documentation establishing the actual costs incurred by the Lot 22 owner in connection with such repair and maintenance. Only reasonable and actual maintenance and repair costs comparable to normal and customary expenses for BDO Project roads (non-dedicated development roads) shall be shared by the three lot owners. The owner of Lot 22 shall submit an annual budget for maintenance and repairs to the owners of Lots 19 and 21 prior to October 1st of each year, which budget shall identify any major repairs or replacements reasonably anticipated for the upcoming budget year. The annual budget shall be approved by all owners by November 30th of each year. Any additional repairs and maintenance items not identified in said budget will be submitted and approved by all owners prior to work being done.

At such time as any portion of this easement becomes subject to a easements dedicated by the Grantor, or its successors and assigns, to Ogden City by means of a recorded subdivision plat, this grant of easement shall terminate and be superceded by the dedication provided on such plat.
