NORTH DAVIS COUNTY SEWER DISTRICT a Utah Special Service District, organized and existing under the laws of the State of Utah, with its principal office at 4252 West 2200 South, Syracuse City, County of Davis, State of Utah, Grantor, hereby QUIT CLAIMS to Syracuse City of 1979 West 1900 South Syracuse City, County of Davis, State of Utah, Grantee, and its successors and assigns, for the sum of \$10.00 and other good and valuable consideration the following described tracts of land in Davis County, State of Utah:
