## **DEED RESTRICTION**

THIS DEED RESTRICTION (the "Restriction") is made and effective as of <u>3rd</u> day of <u>December</u> 1999, by <u>Utah Nonprofit Housing Corporation</u>, a nonprofit organization of the State of Utah ("Subrecipient"), for the benefit of SALT LAKE COUNTY (the "County"). For good and valuable consideration, Subrecipient hereby agrees as follows for the benefit of the County:

- A. Property encumbered. The restriction shall be recorded against that certain real property located at 500 East 3584 South, Salt Lake City, Utah 84115 in Salt Lake County, Utah as more fully described on Exhibit "A" attached hereto and incorporated herein. That real property and all improvements constructed thereon are hereinafter collectively called the "Property".
- B. Nature of Restriction. The Property shall remain affordable for twenty years as specified in the Subrecipient Agreement (Salt Lake County Contract BV9926c) of a HOME Investment Partnerships Program date as of \_\_\_\_\_\_\_, 1999, by and between Subrecipient and the County (the "Agreement"). A copy of the Agreement can be obtained from the County at the address set forth above.
- C. Term. The restriction shall run with the title to the Property and shall be binding upon the successors, assigns and beneficiaries of the parties. The Property shall be encumbered by the Restriction until (the "Termination Date"): December 31, 2020. Upon the Termination Date, this restriction shall automatically terminate without need for any other documentation, notice or recorded material. Nevertheless, Subrecipient and the County shall promptly cooperate together and take the actions and sign the documents that either of them deems necessary to terminate the Restriction and remove all record thereof from the title of the Property.
