NOTICE OF ADOPTION OF REDEVELOPMENT PLAN ENTITLED "EDISON STREET NEIGHBORHOOD DEVELOPMENT PLAN" AND DATED NOVEMBER 17, 1982.

Pursuant to Section 11-19-32.1, Utah Code Annotated, 1953, as amended, the following information is recorded in the Office of the Recorder of Salt Lake County:


(1) A Description of the Land Within the Project Area.

Commencing at the Southeast corner of the intersection of State Street and Twenty-Seventh South Street; thence South along the East property line of State Street to the Northeast corner of the intersection of State Street and Sunset Avenue; thence East along the North property line of Sunset Avenue 125 feet; thence North 95 feet; thence East 350 feet; thence North 196.68 feet to the South property line of Claybourne Avenue; thence North 50 feet to the North property line of Claybourne Avenue; thence West approximately 197.8 feet to the Northeast corner of the intersection of Claybourne Avenue and Edison Street; thence North along the East property line of Edison Street to the Southeast corner of the intersection of Edison Street and Twenty-Seventh South Street; thence West along the South property line of Twenty-Seventh South Street to the point of Beginning, all of the above property located in the City of South Salt Lake, Salt Lake County, Utah, according to the official records.

(2) A Statement that the Redevelopment Plan for the Project Area has been Approved. The City Council of South Salt Lake City has adopted a redevelopment plan entitled "Edison Street Neighborhood Development Plan" dated November 17, 1982 by Ordinance No. 105, dated December 15, 1982.

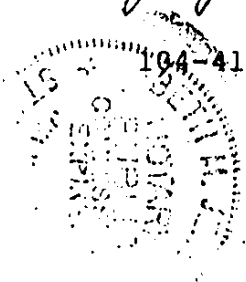
