## AGREEMENT

WHEREAS, certain land interests owned separately by Salt Lake City Suburban Sanitary District, Zions Securities Corporation, and Vitro Uranium Company, a Division of Heavy Minerals Co., a Delaware corporation, on the South side of Mill Creek Stream in the Northeast Quarter of Section 26, Township 1 South, Range 1 West, Salt Lake Base and Meridian, describe the North boundary line thereof as the center line of Mill Creek Stream and as running North 850 49' West or South 850 49' East and,

WHEREAS, certain land interests owned by Denver and Rio Grande Railroad Company and Rio Grande Land Company, on the North side of said Mill Creek Stream describe the South boundary lines thereof as running along the center of Mill Creek Stream and as running North 83° 16' West or South 83° 16' East and,

WHEREAS, the common boundary lines between parties on the South and on the North of Mill Creek Stream are not properly described as common boundary lines, and

WHEREAS, it is the intention of all of the foregoing parties that the center of Mill Greek Stream should be the common boundary line between the property owners on each side of said Stream.

NOW, THEREFORE, it is hereby agreed by and between all of the parties hereto that the North boundary of the properties on the South side of Mill Creek Stream shall be and is the center of said Stream and the South boundary of the properties on the North side of Mill Creek Stream shall be and is the center of said Stream and that the properties on the two sides of said Mill Creek Stream and that the properties on the two sides of said Mill Creek Stream border each other with a common boundary line between them as above set forth.

This agreement consists of four sections which are to be considered as a unit, each section is to be signed by one or two parties.
