Grant to Construct Electric Transmission Line.

This indenture, made this 21<sup>st</sup> day of November, 1912, between P.A. Sorenson, Company, a corporation organized and existing under the laws of the State of Utah, herein after called the grantor, of the one part, and Utah Power Company, a corporation organized and existing under the laws of the State of Maine, herein after called the grantee, of the other part, Witnesseth:

Whereas the said grantor is the owner in fee of an undivided one half interest of, in and to the E. 1/2 of the N.E. 1/4 of Section 17, Twp. 1 S. R. 2 E.; S.L.B. & M., in Salt Lake County, State of Utah;

And whereas the said grantee has erected a line of poles, on which is strung wires for the transmission of its electric current for the furnishing of electricity and electric power, across said above described parcel of land, and requires a grant of an easement over said land for the said line, from said grantor.
