ASSIGNMENT

That the Assignor in consideration of the sum of ONE DOLLAR (\$1.00) and other good and valuable consideration, to it paid by the Assignee, the receipt of which is hereby acknowledged, does hereby grant, convey, assign, transfer and set over, but without warranty, unto the Assignee, its successors, assigns, lessees and agents, all rights, privileges and easements which the Assignor has or may have by virtue of the grants, deeds, indentures, releases and receipts hereinafter set forth, to construct, operate, maintain, replace and remove such Communication Systems as the Assignee may from time to time require, consisting of underground cables, wires, manholes, drains, splicing boxes, surface testing terminals, repeaters, repeater housings, markers and other appurtenances, upon, over and under property located in the Counties of Salt Lake and Summit, State of Utah, the nature and extent of said rights, privileges and easements, and the lands affected thereby being more particularly described in the grants, deeds, indentures, releases and receipts listed in Exhibit "A", attached hereto, and hereby made a part hereof, the originals of which are delivered to the Assignee simultaneously with these presents.

TO HAVE AND TO HOLD the rights of way and easements herein granted unto the Assignee, its successors, assigns, lessees and agents, to its and their own use and behoof forever.

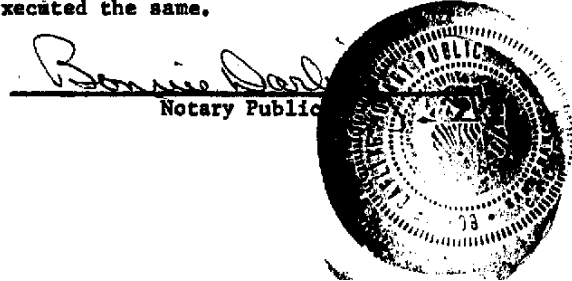
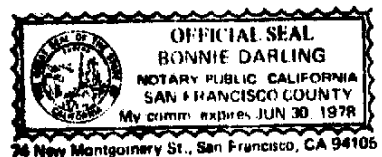
