## EASEMENT

MALT INVESTMENT COMPANY, L.C., a Utah Limited Liability Company, Grantor, hereby GRANTS and CONVEYS to LEHI CITY, a municipal corporation of the State of Utah, Grantee, for the sum of Ten Dollars, and other good and valuable considerations, a perpetual easement and right-of-way for buried power, signal infrastructure, and any other utilities, roadway construction, and any related facilities, over, under, and through the following described real property situated in Utah County, State of Utah, and more particularly described as follows:

a 10.00-foot wide easement across a portion of that Real Property described in Entry Number 7920:2018 of the Official Records of Utah County, located in the NE1/4 of Section 6, Township 5 South, Range 1 East, Salt Lake Base & Meridian, located in Lehi, Utah, more particularly described as follows:

Beginning at a point in the easterly boundary line of the Grantor's property, which point is located 1385.00 feet S. 0°00'00" W. and 13.11 feet S. 90°00'00" W. and 128.94 feet S. 0°09'42" W. and 327.61 feet S. 7°33'16" W. and 43.08 feet S. 26°36'20" W. and 177.70 feet N. 9°19'52" E. and 4.27 feet N. 0°35'14" E. and 10.00 feet N. 89°24'46" W. from the Northeast corner of Section 6, Township 5 South, Range 1 East, Salt Lake Base and Meridian; and running thence 27.68 feet along the arc of a 35.00-foot radius curve to the right (Note: chord to said curve bears S. 67°39'31" W. 26.96 feet); thence N. 0°18'54" E. 10.00 feet; thence 39.15 feet along the arc of a 25.00-foot radius curve to the left (Note: chord to said curve bears N. 45°27'04" E. 35.27 feet); thence S. 0°35'14" W. 24.49 feet to the point of beginning.

The above described easement contains 301 square feet in area or 0.007 acres.

Basis of Bearing: S. 0°03'00" W. from the Northeast Corner of Section 6, Township 5 South, Range 1 East, Salt Lake Base & Meridian to the East Quarter Corner of said Section 6.

THIS EASEMENT IS GRANTED IN CONSIDERATION for the construction of the above described utilities and roadway construction for the improvement of real property owned by the Grantor(s). The property of Grantors shall be restored in as good condition as when the same was entered upon by the Grantee or its agents.

GRANTORS HEREBY AGREE that Lehi City shall have the right of ingress to and egress from the property above described for the purpose of constructing, maintaining, and repairing said public utilities, roadway and related facilities, to be located on the above-described property. Grantors also agree not to construct or maintain any building, structure, or trees of a permanent nature upon the property above described.

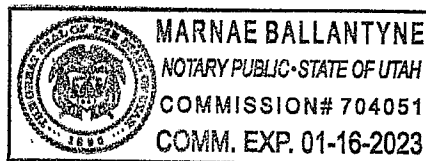
