The United States of America, To all to whom these presents shall
come, Greeting:

Whereas, by the act of Congress approved July 1, 1862, as
amended by the act of July 3, 1864 to aid in the construction of a
railroad and telegraph line from the Missouri River to the Pacific
Ocean to secure to the Government the use of the same for postal,
military and other purposes, authority is given to the Union Pa-
cific Company to construct a railroad and telegraph line under
certain conditions and stipulations as expressed in said acts; and
provision is made for granting to the said company every alter-
nate section of public land designated by odd numbers to
the amount of ten alternate sections per mile on each side of the
said railroad, on the line thereof, and within the limits of two
miles on each side of said road, not sold, reserved, or otherwise
disposed of by the United States, and to which a Preemption or Home
stead claim may not have attached at the time the line of said road
is definitely fixed.

And Whereas an affidavit statement bearing date November
3rd 1889, and verified by the signature of the Secretary of the
Interior has been filed in the General Land Office, showing that
the Commissioners appointed by the President, under provisions
of the act of Congress of July 1, 1864, approved July 1, 1864

have reported to him that a portion of the line of railroad and telegraph from Omaha in the State of Nebraska, Westward to Ogden in the Territory of Utah and known as the Union Pacific Railroad has been constructed and fully completed and equipped in the manner prescribed by the acts of Congress relative to the Pacific Railroad and Telegraph line; and the said Union Pacific Railroad Company, has applied for a conveyance of the title to the lands granted to said Company by the said acts of Congress of July 1, 1862 and July 2, 1864;

And Whereas, certain tracts have been stipulated, under the acts aforesaid, by Oscar T. Davis, the Agent for the said Union Pacific Railroad Company as shown by his original list of selections dated August 19, 1876, certified under date of August 31, 1876, by the Register and Receiver at Salt Lake City, Utah, territory. The said tracts being described as follows, to wit:

North of base line and West of Salt Lake Principal Meridian.

Township One, Range One.

East half of the North East quarter, south West quarter, and West half of the South East quarter of Section One containing Three hundred and twenty acres.

East half of Section three, containing three hundred and sixteen acres and forty hundredths of an acre.

North East quarter of Section nine, containing one hundred and sixty acres. West half of Section eleven containing Three hundred and twenty acres.

South half of the North West quarter and the South West quarter of Section thirteen, containing two hundred and forty acres. Lots numbered one and six of Section fifteen, containing forty-four acres and forty-four hundredths of an acre.

Now Know ye, the United States of America, in consideration of the premises and pursuant to the said acts of Congress, Have Given and Granted and by these presents Do give one Grant, unto the Union Pacific Railroad Company and to its assigns, the tracts of lands selected as aforesaid and described in the foregoing: (yet excluding and excepting from the transfer by these presents, "All mineral Lands", should any such be found to exist in the tracts described in the foregoing; but this exclusion and exception according to the terms of the statute, shall not be construed to include "Coal and Iron Lands")

To Have and to Hold, the said tracts with the appurtenances unto the said Union Pacific Railroad Company and to its assigns forever, with the exclusion and exception as aforesaid.

In Testimony Whereof, I, Ulysses S. Grant President of the United States, have caused these letters to be made patent, and cause the seal of the General Land Office to be hereunto affixed.
