PARTNERSHIP, a Utah limited partnership, the owner of certain real property located in the County of Salt Lake, State of Utah, more particularly described in Exhibit "B" attached hereto and by this reference made a part hereof, for the sum of ONE (\$1.00) DOLLAR and other good and valuable consideration by each to the other paid, the receipt and adequacy of which is hereby acknowledged, do hereby grant to each other a NON-EXCLUSIVE PERPETUAL EASEMENT AND RIGHT-OF-WAY, in common with others, and to run with the land and which shall be for the benefit and use of the owners of and be appurtenant to each of the separate parcels set forth on Exhibits "A" and "B" attached hereto, and which shall be used for access and driveway purposes for pedestrian and motor vehicle traffic over and across the following described tracts of land situate in the County of Salt Lake, State of Utah, to-wit:

RIGHT-OF-WAY #1 -- A 30 foot wide right-of-way being 15 feet either side of the following described centerline:

Beginning at a point on the East line of Lot 8, Salt Lake International Center Plat 2A, said point being North 0°16'02" West, 219.04 feet from the Southeast corner of said Lot 8, and running thence South 89°58' West, 393.50 feet.

RIGHT-OF-WAY #2 -- A 30 foot wide right-of-way being 15 feet either side of the following described centerline:

Beginning at a point of the North line of Lot 7, Salt Lake International Center Plat 2A, said point being North 89°58' East, 122.42 feet from the Northwest corner of said Lot 7, and running thence South 0°02' East, 363.96 feet.

RIGHT-OF-WAY #3 -- A 30 foot wide right-of-way being 15 feet either side of the following described centerline:

Beginning at a point which lies 219.21 feet North and 284.79 feet East of the Southwest corner of Lot 7, Salt Lake International Center Plat 2A, and running thence South 0°02' East, 208.4 feet.

In consideration of the mutual, reciprocal and non-exclusive easement herein granted and as a condition precedent to the use and enjoyment thereof, each and every owner of any part of the real property described in Exhibit "A" and/or Exhibit "B" shall share, on an equal basis, all costs and expenses of the maintenance of the easement premises including, without limitation, all public liability insurance premiums, electricity, cleaning and janitorial work, snow removal, repairs and replacements, including resurfacing and restriping, maintenance of lights and light standards and all other functions necessary for the proper maintenance, upkeep and operation of the said easement premises.

The granting of this easement and right-of-way does not provide access to the dedicated and public roads to which it connects; such access, particularly as it relates to North Temple Street, being subject to the control and consent of the applicable public entity.

The foregoing easement and right-of-way shall be binding upon the parties hereto, their successors and assigns.
