FOR THE SUM OF TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, Grantor hereby conveys to Grantee a perpetual, nonexclusive right-of-way and easement for the purpose of conveying irrigation water within an existing reinforced concrete pipe under certain real property located in Utah County, Utah, described as follows:

A 16.00 foot easement 8.00 feet on each side of the following-described centerline: Commencing at a point located South 01°05'18" East along the one-quarter Section line 766.51 feet and West 1016.71 feet from the North one-quarter corner of Section 27, Township 6 South, Range 2 East, Salt Lake Base and Meridian, and running thence South 40°06'43" East 189.11 feet; thence South 38°16'23" East 499.46 feet to a point located South 01°05'18" East along the one-quarter Section line 1303.35 feet and West 595.69 feet from the North one-quarter corner of said Section 27.

IF ANY PARTY brings suit to enforce or interpret this instrument or for damages on account of the breach of any provision of this instrument, the prevailing party shall be entitled to recover from the other party its reasonable attorneys' fees and costs incurred in any such action or in any appeal from such action, in addition to the other relief to which the prevailing party is entitled.
