RIGHT OF ENTRY AGREEMENT

It is understood and agreed that this permission is granted without prejudice to any rights of the undersigned, pending a settlement or judgement as to the amount of compensation to be paid the Grantor for said property, and as to any other amounts to which the Grantor is entitled. It is further agreed that if a satisfactory settlement cannot be agreed upon, the UTAH DEPARTMENT OF TRANSPORTATION, upon request from the undersigned, will proceed at once to commence and diligently prosecute a condemnation proceeding in the appropriate court for the judicial determination of such compensation.

It is further understood that statutory interest shall be paid from the date of this Right of Entry Agreement on any additional amounts of money that may be paid in the final settlement or judgement. Also, the date of this Right of Entry Agreement shall be the valuation date for the determination of fair market value the of property mentioned in the Exhibits .

It is further understood that if an amiable agreement has not been mutually reached within six months from the date of this Right of Entry agreement, the UTAH DEPARTMENT OF TRANSPORTATION will proceed to commence and diligently prosecute a condemnation proceeding in the appropriate court.


