EASEMENT

in consideration of \$10.00 and other valuable consideration, hereby grants to Pacificorp, an Oregon corporation, its successors and assigns, Grantee, a perpetual easement 10 feet in width for the erection, operation, maintenance, repair, alteration, enlargement, inspection, relocation and replacement of electric transmission lines, distribution lines, communication lines and fiber optics, of one or more wires or fibers and all necessary or desirable appurtenances, including but not limited to towers, poles, props, equipment cabinets, pole mounted transformers, guys, anchors, and other supports, along the general course located or constructed by Grantee over the following described real property located in Utah County, State of Utah, or as more particularly described and/or shown on attached Exhibit(s) A by the reference made apart hereof:

A right of way 10 feet in width, being 5 feet each side of the following described survey line:

Beginning at a pole in an existing powerline on the Grantor's land at a point 4 feet north and 756 feet east, more or less, from the south one quarter corner of Section 24, T.5 S., R.1 W., S.L.M., thence N.75°46'E. 109.6 feet, thence N.0°07'W. 967.3 feet, thence N.46°52'W. 38.8 feet, thence N.89°47'W. 501.3 feet, thence N.0°22'E. 441.2 feet on said land and being in the W1/2 of the SE1/4 of said Section 24.

The within easement shall include: The right to place all or any part of such lines underground and the right to install and maintain guys and anchors outside said easement.

Together with all right of ingress and egress over lands of the Grantor necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted and all rights and privileges incident thereto, including the present and future right to clear and cut timber, trees, brush, overhanging branches, fire hazards, structures and other obstructions which may injure or interfere with the Grantee's use, occupation, or enjoyment of this easement. Title to trees and merchantable timber hereafter growing within the right of way shall become the property of Grantee.

At no time shall any fires be permitted, nor flammable material be placed or stored within the easement area, provided, however, that vegetative fire hazards shall not include agricultural crops.

At no time shall any permanent buildings or structures of any kind be placed or erected within the boundaries of said easement, nor shall any equipment or material of any kind that exceeds 12 feet in height be temporarily placed or used thereon by Grantor or by Grantor's heirs, successors or assigns.
