of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant  
to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing  
under and by virtue of the laws of the State of Utah, Grantee, for the sum of One dollar and other  
consideration \_\_\_\_\_ DOLLARS (\$ 1.00 ) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right  
of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through  
and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:

Beg at a pt due W 1.50' & due N 614.68' from the SW cor sec. 28, T 1S, R 1E, S.L. B & M,  
said pt being due S 482.342' and due E 267.859' from monument in intersection of 1300 E.  
& 3300 S. Sts; thence N 79.55'; thence N 88°53' E, 150.246; thence S. 218.50'; thence  
S 89° E 55.87'; thence S 88°02' E 94.13'; thence due N 358.887'; thence due W 156.66';  
th parallel to 1300 E St. N 0°18'43" E 232.054' to a pt on S. line of 3300 S. St; th  
S 89°48'36" W 82.50' alg said So. line; th S 0°18'43" W 199.00', th par. to 3300 So.St.  
S 89°48'36" W 165.00'; th S 0°18'43" W 58.201'; th S 89°48'36" W 132.299' to a pt on E.  
line of 1300 E St.; th alg said E. line S 0°18'43" W 131.80', th. S 35°22' E 64.825'; th  
E 199.676' to pt. of beg.

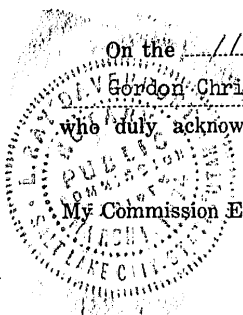
the center line of said pipe shall extend through and across the above land and premises on a line
