Right of way for highway known as N.H.S. Project No. 160, across the grantor's land in the SE 1/4 of Section 26, T. 5 N., R. 2 W., S. 4 B. 3 W. Said right of way is a strip of land 33 ft. wide, 33 ft. on the south side of the center line of survey of said highway. Said center line is more particularly described as follows:

Right of way for highway known as H.R.S. Project No. 160, across the grantors' land in the SE 1/4 of Section 26, T. 5 N., R. 2 E., S. 1 B. 24M. Said right of way is a strip of land 33 ft. wide, 33 ft. on the south side of the center line of survey of said highway. Said center line is more particularly described as follows:

Beginning at the intersection of the east boundary line extended of said grantors' land and said center line of survey at Engineer's Station 14+02, which point is 1402 ft. west along the center line of said survey from the east 1/4 corner of said Section 26; thence west along the approximate center of the present road a distance of 1163 ft. to the intersection of said center line of survey and the west boundary line extended of said grantors' land at Engineer's Station 25+65, which point is 2565 ft. west along the center line of said survey from the east quarter corner of said Section 26, as shown on the official map of said project on file in the office of the State Road Commission of Utah.
