

East along said right-of-way line parallel with and 3 rods distant from the center line of tract, 2329 feet to the East line of Section 3, of said Township and Range, thence South 720 feet to the Northeast corner of said Section 10, and beginning, containing 68.4 acres, more or less, and the Corporate limits of said Town of Clearfield are hereby extended so as to include the aforesaid tract and territory.

Section 2.

That this Ordinance shall become effective immediately upon publication or posting thereof as required by law.
