of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for the sum of one dollar and other valuable consideration DOLLARS (\$ 1.00) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in: beginning at a point which is N 0°05'44" E 410.63 ft along the W line of 900 E. St. and S 89°54'14" W 385.11 ft from the SE corner of Lot 1, Block 5, 10 Acre Plat "A", BFS and running thence S 89°54'14" W 385.11 ft to the W line of said Lot 1, thence along said W line of Lot 1 N 0°09'58" E 171.54 ft N 89°54'14" E 385.11 ft; thence S 0°07'51" W 171.54 ft to the point of beginning

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows: wherever main sewer lines are laid to serve two or more buildings
