WHEREAS, a feasibility consultant selection committee was duly established pursuant to Section 10-2-106, Utah Code Annotated, 1953 as amended, and Hubble Engineering was selected as a feasibility consultant by said selection committee, and

WHEREAS, the feasibility consultant completed its feasibility study pursuant to the requirements of Section 10-2-106, Utah Code Annotated, 1953 as amended, and

WHEREAS, the Board conducted public hearings on the feasibility results pursuant to Section 10-2-108, Utah Code Annotated, 1953 as amended;

NOW, THEREFORE, be it Resolved by the Board of County Commissioners of Utah County, Utah, as follows:
