ABSTRACT OF FINDINGS AND ORDER BY: ZJM, DEPUTY - MA 1 P.

I, Diana Hansen, being duly sworn, deposed, and say that I am the Secretary of the Salt Lake City Housing Appeals and Advisory Board, and that on the 13th Day of February 2008, Case Number: H-04-06 was heard by the Board. The Appellant, Kevin B. Merrill, requested on the property address of 140 East 2nd Avenue, Salt Lake City, an appeal on:

- The headroom height for the stairway that leads to the 2nd floor is deficient.
- The risers in the same stairway exceed the variation in rise and exceed the maximum allowed rise.
- The guardrail at the top of the stairway that leads to the attic units is insufficient in height.
- The handrail for the main entrance and stairway that leads to the upper units is deficient in height.
- The ceiling height over the bathtub in Units #5 & #6 are insufficient as to headroom.

DECISION:

- Granted appeal for insufficient headroom height because to increase the headroom would require major changes to the plumbing and electrical systems, provided the low point is posted with reflective tape.
- Granted appeal for excessive rise and variation in rise because to change the stairway to meet code requirements for rise would exacerbate the deficiency in headroom.
- Granted appeal for insufficient guardrail height because the stairway appears to be part of the original construction.
- Granted appeal for insufficient height of the handrail that leads to the upper units because the historical significance of the stairway would be compromised if changed.
- Granted appeal for insufficient headroom height over the bathtubs because it would require
 Historic Landmark Commission approval to change the roof line and it would be structurally
 impractical.
