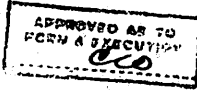
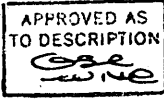

Naomi Fox, Grantor, of Utah County, Utah, hereby convey and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission, distribution, telephone and telegraph circuits of the Grantee, and two two pole towers and four guy anchors with the necessary guys, stubs, cross arms, braces and other attachments affixed thereto, for the support of said circuits, on, under, over, through, and across a tract of land fifty (50) feet in width, located in Utah County, Utah, and being twenty-five (25) feet on each side of the following described center line:

Beginning at fence on north boundary line of Grantor's land at a point 1225 feet north and 1550 feet east, more or less, from the southwest corner of Section 12, T. 5 S., R. 1 W., S.L.B. & M., thence running S. 18°33' E. 102 feet, thence S. 41°57' E. 1491 feet to south boundary line of Grantor's land at north fence line of County Road and being in the SE 1/4 of the SW 1/4 of said Section 12.
