JOHNSON and AGNES JOHNSON, his wife, and UTAH CONSOLIDATED MINING COMPANY, dated November 14, 1908, and recorded on November 20, 1908 at Book "B" of Liens & Leases, Page 492, Records of Tooele County, Utah, and covering the following described real property located in Tooele County, Utah, to-wit:

The Northwest Quarter of SECTION 15 in TOWNSHIP 3 SOUTH, RANGE 4 WEST of the Salt Lake Base and Meridian, containing 158 acres of land, 2 acres having been deeded to County for a county road. Excepting right of way deeded to S.P.L.A. & S.L. Railway.
