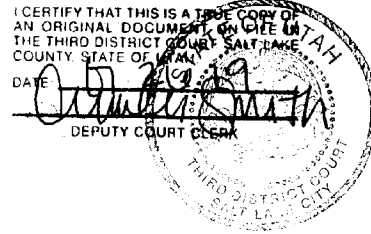

Petitioner Vauna Lee Peterson's (hereinafter "Petitioner"), Motion for Fourth Order to Show Cause came before Commissioner Luhn the Court for a hearing on April 22, 2019, Tyler S. Foutz, appeared as counsel for Petitioner. Respondent Mr. Scott D. Peterson was not represented and failed to appear.

Having reviewed the documents submitted in connection with the motion, heard the arguments of Petitioner's counsel, and good cause appearing therefore, **HEREBY ORDERS:**

FINDINGS

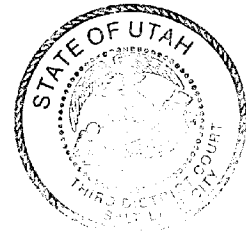
1. Respondent is delinquent on his alimony obligations to Petitioner in the amount of at least \$31,419.00;
2. Respondent is in contempt.
3. Respondent has 60 days to purge contempt by filing petition to modify (and) filing complete financial declaration w/attached supporting documents (and) scheduling further hearing. Respondent's failure to purge his contempt may result in 60-day jail sentence.
4. Petitioner has incurred attorney fees in bringing the Fourth Order to Show Cause before the Court and is entitled to reimbursement for her attorney fees.
5. The commissioner certified Respondent's Contempt for a finding by the Court to hold Respondent in contempt of Court;

ORDERS

6. Respondent is held in contempt of court of his failure to comply with an Order of this court, namely, payment of alimony as provided in the parties' divorce decree;
7. Judgment is hereby entered against respondent in the following amounts:

Balance of Unpaid Alimony through May 31, 2019	\$33,270.23
Attorney Fees for Fourth Order to Show Cause (January 21, 2019 to June 5, 2019)	\$1,238.00
Costs associated with Service of Fourth Order to Show Cause	\$50.00
Total	\$34,558.23

8. Respondent shall continue to pay Alimony as ordered by the Court (entered on or about October 22, 2013);

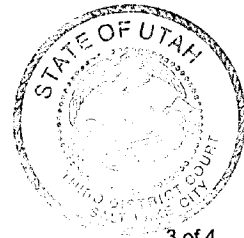

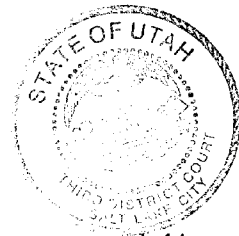


