EASEMENT

J. Ernest Jensen and Rachel L. Jensen, his wife, Grantor,  
of Wallsburg, County of \_\_\_\_\_, State of Utah,  
hereby grant and convey to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of  
Four hundred and eighty-three and no/100 Dollars,

an easement upon part of an entire tract of property in the NW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub> of  
Section 1, T. 3 S., R. 1 W., S.L.B. & M., in Salt Lake County, Utah, for the  
purpose of constructing thereon an irrigation facility and appurtenant parts  
thereof incident to the construction of a highway known as Project No. 0151.

Said part of an entire tract is a strip of land 15.0 ft. wide,  
adjoining southerly the following described portion of the southerly right  
of way line of said project:

Beginning on the east boundary line of said entire tract at a point  
20.3 ft. south and 308.24 ft. west from the NE. corner of said NW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub>;  
thence S. 78° 49' 15" W. 425.0 ft. to a point 115.0 ft. perpendicularly  
distant southerly from the center line of said project at Engineer Station  
104+88.52; thence S. 89° 53' 45" W. 180.0 ft.

The above described easement contains 0.21 acre, more or less.

After said irrigation facility is constructed on the above described  
part of an entire tract at the expense of said State Road Commission, said  
State Road Commission is thereafter relieved of any further claim or demand  
for costs, damages or maintenance charges which may accrue against said  
irrigation facility and appurtenant parts thereof.

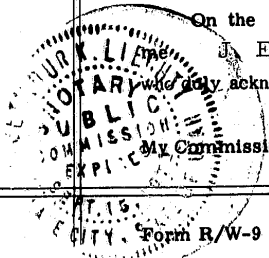
