TO PROTECT THE SECURITY OF THIS TRUST DEED, AND FOR OTHER PURPOSES, TRUSTOR AGREES:

- Trustor covenants, warrants and agrees with Beneficiary, and its successors and assigns, 1. that Trustor owns the Trust Property in fee simple free from any lien or encumbrance with a priorty superior to that of this Trust Deed (except those existing at the time Trustor takes title to the Property or those expressly consented to by Beneficiary, which consent shall be in Beneficiary's sole and absolute discretion), that this Trust Deed is and will remain a valid and enforceable first priority lien on the Trust Property, that Trustor, at its expense, will preserve such title and will maintain this Trust Deed as a first and paramount lien upon the Trust Property during the term hereof and will warrant and defend the validity and priority of the lien hereof against the claims of all persons and parties whomsoever. 
