# SUPPLEMENTAL DECLARATION OF EASEMENTS, COVENANTS, CONDITIONS, AND RESTRICTIONS

MOUNTAIN HEIGHTS AT ROSECREST A Planned Unit Development Herriman, Utah Phases 5 and 6

THIS SUPPLEMENTAL DECLARATION OF EASEMENTS, COVENANTS, CONDITIONS, AND RESTRICTIONS (this "Supplemental Declaration") is made this <u>20</u> day of January, 2016, by WASATCH LAND COMPANY, a Utah corporation ("Declarant").

#### RECITALS

- A. Declarant previously executed and recorded that certain Declaration of Easements, Covenants, Conditions and Restrictions dated September 9, 2014, recorded on September 9, 2014, as Entry No. 11910505 in Book 10258 at Page 9852 of the Official Records of Salt Lake County, State of Utah (the "Official Records"), as supplemented (collectively the "Declaration"). The Declaration pertains to certain real property commonly known as Mountain Heights at Rosecrest and more particularly described on Exhibit A attached hereto and incorporated herein by this reference ("Phases 1, 2, 3 and 4"). All real property subject to the Declaration from time to time is referred to herein as the "Development". Capitalized terms used but not otherwise defined herein shall have the meanings given them in the Declaration.
- B. Article III of the Declaration provides that the Declarant thereunder may annex into the Development any Additional Property by recordation of a Supplemental Declaration.
- C. Declarant owns certain real property ("Phase 5") more particularly described on Exhibit B, and that certain real property ("Phase 6") more particularly described on Exhibit C, each attached hereto and incorporated herein by this reference and depicted on a subdivision plat recorded at the Office of the Recorder of Salt Lake County, State of Utah.
- D. Pursuant to Article III of the Declaration, Declarant desires to annex Phases 5 and 6 into the Development and subject it to all the provisions of the Declaration, except as expressly set forth herein.

### 1. ANNEXATION

As of the date on which this Supplemental Declaration is recorded, all property included within Phases 5 and 6 is annexed into the Development and subjected to the provisions of the

Declaration, all of which are hereby incorporated into this Supplemental Declaration as if such provisions were fully set forth herein, pursuant to Article III of the Declaration, and the parties hereto hereby declare that all of the property included within Phases 5 and 6 is and shall continue to be held, conveyed, hypothecated, encumbered, leased, rented, used, occupied, and improved subject to the limitations, covenants, conditions, restrictions, and easements set forth in the Declaration, as the Declaration may be amended from time to time, all of which are declared and agreed to be in furtherance of a general plan established for the preservation of the values of Lots and Common Areas within the Development, and for the maintenance of any private roadways, sidewalks, open spaces, and all other Common Areas therein, if any. The Owner of each Lot within Phases 5 and 6 shall have and be subject to all the rights, powers, and responsibilities of Owners under the provisions of the Declaration.

#### 2. **GENERAL PROVISIONS**

- The provisions of this Supplemental Declaration shall continue in effect for so 2.1 long as the Declaration continues in effect.
- This Supplemental Declaration as well as any amendment hereto and any valid 2.2 action or directive made pursuant thereto, shall be binding on each party hereto and on the
