Taylor, Jr., and wife, Gladys M., Grantors of Weber County, State of Utah, hereby warrant and convey unto Ogden City, a Municipal Corporation of the State of Utah, Grantee, a temporary right of way, for the construction of a sewer line one hundred (100) feet wide along the course of the hereinafter described line, and a perpetual right of way twenty five (25) feet wide, the same being twelve and one half (12 $\frac{1}{2}$) feet on each side, along the following described course, to-wit: A part of the Southwest Quarter of Section 17, Township 6 North, Range 1 West, Salt Lake Meridian, United States Survey.
