Grantor, do hereby convey to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over and across a tract of land located in Tooele County, Utah, described as follows:

One guy anchor located on the Grantor's land at a point 370 feet north and 750 feet west, more or less, from the east one quarter corner of Section 16, T.3 S., R.4 W., S.L.M. and being in the SE 1/4 of the NE 1/4 of said Section 16.

One guy anchor located on the Grantor's land at a point 1220 feet north and 635 feet west, more or less, from the east one quarter corner of Section 16, T.3 S., R.4 W., S.L.M. and being in the SE 1/4 of the NE 1/4 of said Section 16.

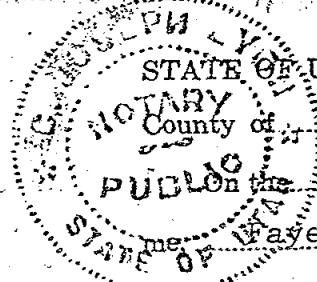
