*Five and one-half thousand dollars*, in consideration of which the undersigned hereby grant and convey unto said Company, its associates and allied corporations, its and their respective successors, assigns, licensees and agents, a right of way and easement to construct, operate, maintain, replace and improve such communication systems as the grantees may from time to time require, consisting of underground cables, wires, conductors, splices, sheathed and unspliced hoses, and surface testing-terminal, repeaters and markers, and other appurtenances, upon, over and under a strip of land one rod wide across the land which the undersigned own or in which the undersigned have any interest in that portion of the Maplewood Addition, and that parcel 70 feet in width immediately East of said Maplewood Addition, Township 1 North, Range 2 West, of S. J. E. & M., County of Salt Lake, and State of Utah.

together with the following rights: Of ingress and egress over and across the lands of the undersigned to and from said strip for the purpose of exercising the rights herein granted; to place surface markers beyond said strip; to clear and keep cleared all trees, roots, brush and other obstructions from the surface and sub-surface of said strip; to install gates in any fence crossing said strip; and to permit in said strip the cables, wires, circuits and the appurtenances of any other company. The northerly boundary of said one rod strip shall be a line parallel to and three feet northerly of the first appurtenances of any other company. The undersigned for itself, its successors and assigns, hereby covenant that no structure shall be erected or permitted on said strip. The grantees agree to pay for damage to fences and growing crops arising from the construction and maintenance of the aforesaid systems. This instrument is executed to grant and convey this right of way and easement with respect to any interest in or claim on the above-described land which Homer Realty Company, or its surviving director, may have.


