

TEN DOLLARS AND NO/100dollars (\$ 10.00) in hand paid by the	
Grantee, the receipt whereof is hereby acknowledged, hereby grants, bargains and conveys unto The Mountain States Telephone and Telegraph Company, a Colorado corporation, 931 14th Street, Denver, Colorado, 80202, Grantee, its successors, assigns, lessees, licensees and agents, a Right-of-Way Easement and the right to construct, operate, maintain and remove such communication and other facilities, from time to time, as said Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to-wit: A five foot (5') easement being 2½ feet on either side of the buried telephone facilities as shown on Exhibit "A" attached hereto and made a part hereof on the following described property: Beginning 104.4 rods West from the Southeast Corner of Section 29, Township 3 South, Range 1 East, Salt Lake Base and Meridian; thence North 1021.38 feet more or less; thence Westerly 414 feet more or less; thence South 468.8 feet; thence South 82° 30' West 399 feet; thence South 471 feet; thence East 797 feet more or less to point of beginning.
