RIGHT OF WAY AGREEMENT

THIS RIGHT OF WAY AGREEMENT made this _______ day of February, 1981, by and between LOUISE FITZGERALD HOLMSTEAD, MARK F. HOLMSTEAD and RHONDA W. HOLMSTEAD, PAUL A. LOGAN and KATHERINE K. LOGAN, WADE H. WEBSTER and LORRIE A. WEBSTER, and RONALD W. VAN OTTEN and HELENE G. VAN OTTEN (hereinafter referred to collectively as "Parties").

WITNESSETH:

WHEREAS, the Parties herein are fee title or contract interest holders in adjoining parcels of real property situated in the Southeast quarter of Section 29, Township 3 South, Range 1 East, Salt Lake Base and Meridian, in Salt Lake County, State of Utah, and described respectively in Exhibit "A" attached hereto and by this reference made a part hereof; and

WHEREAS, the Parties herein desire to create a nonexclusive common right of way, for the sole purpose of ingress and egress, between the herein described adjoining parcels of real property owned respectively by each party for the benefit of each party.

NOW, THEREFORE, for and in consideration of the mutual covenants herein recited, it is mutually agreed by and between the Parties as follows:

1. The Parties hereto do hereby create an easement and right of way in favor of RONALD W. VAN OTTEN and HELENE G. VAN OTTEN and each of the Parties hereto, their heirs and assigns, over that strip of real property more particularly described as follows:

Beginning at a point on the South boundary line of 12400 South Street, said point being South 0°07'25" West 1.75 feet and South 89°59'55" West 1429.24 feet and South 89°51'01" West 128.28 feet and North 0°35'07" West 1007.66 feet from the Southeast corner of Section 29, Township 3 South, Range 1 East, Salt Lake Base and Meridian, and running thence North 89°33'38" West along said South boundary line 24 feet, thence South 0°35'07" East 755.62 feet, thence North 89°51'01" East 24 feet, thence North 0°35'07" West 755.62 feet, more or less, to the point of beginning.

2. The Parties herein do hereby agree that this easement shall be superior and paramount to the rights of any of the Parties hereto and the respective servient estates so created, and the Parties further agree that it is a covenant that shall run with the land.
