his wife, Grantor<sup>s</sup>, do hereby convey to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over and across a tract of land located in Summit County, Utah, along the following described centerline:

Beginning at the north boundary line of the Grantors' land at a point 1405 feet south and 875 feet west, more or less, from the north one quarter corner of Section 26, T.1 N., R.8 E., S.L.M., thence S.56°39'W. 190 feet, more or less, thence S.4°44'E. 91 feet on said land and being in the SE $\frac{1}{2}$  of the NW $\frac{1}{2}$  of said Section 26.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
