GRANT OF EASEMENT

The easement hereby conveyed is for the sole purpose of locating, establishing, constructing and maintaining over, under and across the Easement Area a storm drain line. The need for such improvements has been determined by Riverton City.

The route and course of the storm drain line leading to and from such Easement Area shall be placed in an area that does not affect Grantor's development plans, as set forth in <u>Exhibit Z</u>.

Grantor also agrees to construct for the benefit of Riverton City the following described improvements within the Easement Area and shall, upon acceptance by Riverton City, dedicate to Riverton City the completed improvements described hereafter:

A 24" REINFORCED CONCRETE PIPE BEGINNING AT 13400 SOUTH AND ENDING AT ROSE CREEK

Grantor, its successors, assigns agree to protect and not encumber the Easement Area.

Grantor shall be responsible for all repairs and maintenance of the storm drain line. In addition, Grantor shall be responsible for all repairs to landscaping, curb and gutter, and other surface improvements except for asphalt damaged by Grantee's repair and maintenance activities. Grantee shall be responsible for all repairs to asphalt damaged by Grantee's repair and maintenance activities.

This easement and right of way for the storm drain line shall run with the land and be enforceable against all future owners of the land.


