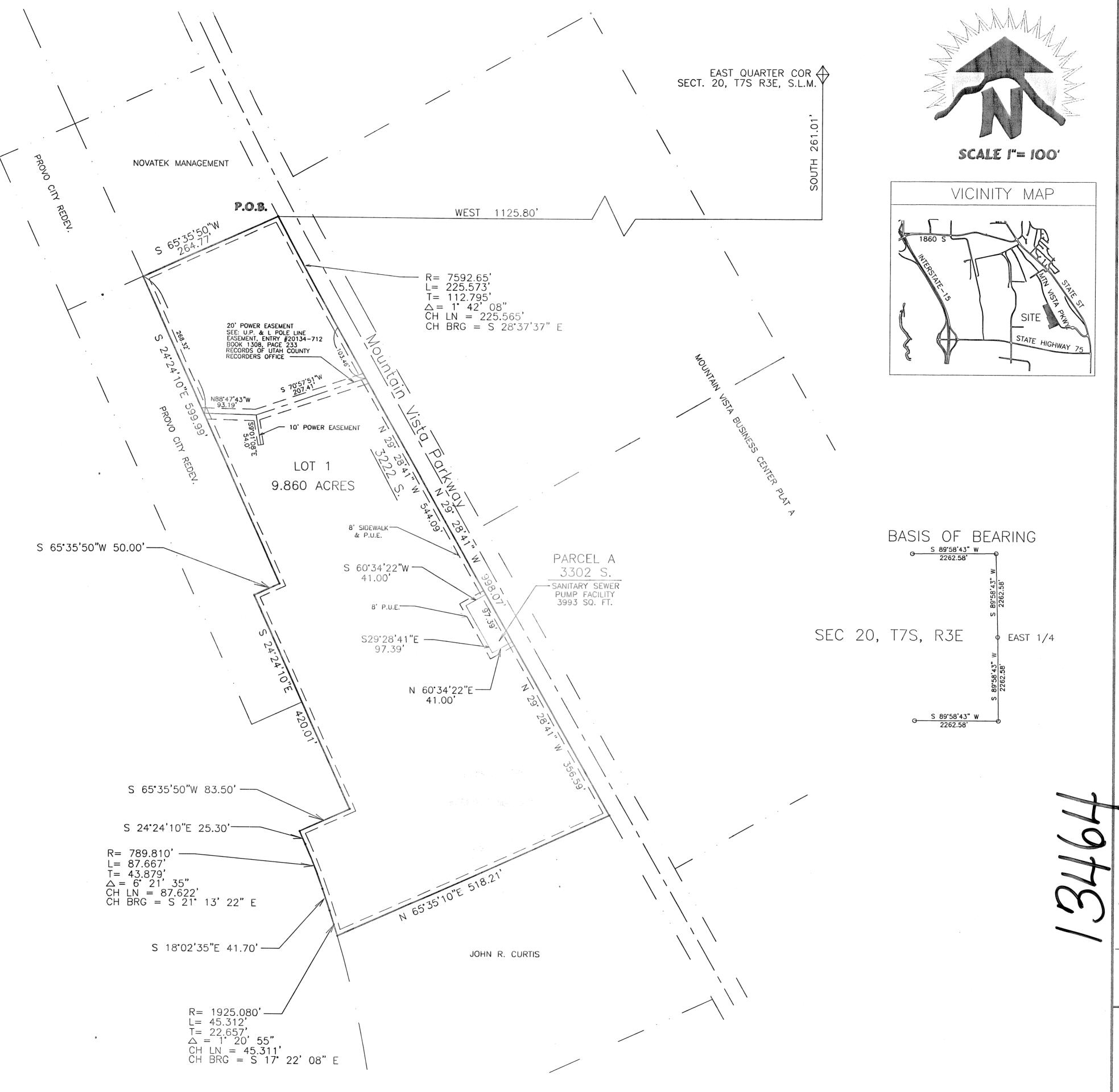

By authority of the owners, I have made a survey of the tract of land shown on this plat and described below, and have subdivided said tract of land into lots, streets and easements.

BOUNDARY DESCRIPTION

The outside boundary of Plat B, Mountain Vista Business Center, located in Provo, Utah County, Utah. Plat B contains two lots, a larger lot 1, containing 9.86 acres and a smaller lot, containing 3,993 square feet. This smaller lot is the site of an existing Sanitary Sewer Pump Station. The east boundary of Plat B is coincident with the west boundary of Plat A and is the west Right of Way line of Mountain Vista Parkway. Said Parkway is described in a Roadway Dedication Plat known as "Mountain Vista Parkway Roadway Dedication" recorded with the Utah County Recorders Office as Entry Number 63343-2006. Map Number 11665. It is also filed with the Utah CountySurveyors Office as a Record of Survey, Number 06-299.

Beginning at a point on the west line of said Mountain Vista Parkway which point is the southeast corner of a parcel of land held by Novatek and described in Warranty Deed # 144856-2005. Said Point of Beginning is South 261.01 feet and West 1125.80 feet from a monument marking the location of the East Quarter Corner of Section 20, Township 7 South, Range 3 East, Salt Lake Meridian.

THENCE South 65 degrees 35 minutes 50 seconds West for a distance of 264.77 feet along the south boundary of said Novatek parcel;

THENCE South 24 degrees 24 minutes 10 seconds East for a distance of 599.99 feet along the east boundary of a parcel held by the Provo City Redevelopment Agency and described in Warranty Deed # 110907-1998 for this course and the next three courses; THENCE South 65 degrees 35 minutes 50 seconds West for a distance of 50.00 feet;

THENCE South 24 degrees 24 minutes 10 seconds East for a distance of 420.01 THENCE South 65 degrees 35 minutes 50 seconds West for a distance of 83.50 feet;

THENCE South 24 degrees 24 minutes 10 seconds East for a distance of 25.30 feet along the east boundary of a 15 foot wide parcel of land held by LKB properties for this course and the next three courses; THENCE along a curve to the right having a radius of 789.81 feet and an arc length of 87.67 feet, being subtended by a chord of South 21 degrees 13 minutes 22 seconds

East for a distance of 87.62 feet THENCE South 18 degrees 02 minutes 35 seconds East for a distance of 41.70 feet; THENCE along a curve to the right having a radius of 1925.08 feet and an arc length of 45.31 feet, being subtended by a chord of South 17 degrees 22 minutes 08 seconds East for a distance of 45.31 feet to the north boundary of a parcel of land held

THENCE North 65 degrees 35 minutes 10 seconds East for a distance of 518.21 feet along said north boundary of the Curtis parcel to a point on the west boundary of said Plat A. This point also being on the west right of way line of Mountain Vista Parkway;

THENCE North 29 degrees 28 minutes 41 seconds West for a distance of 998.07 feet along the west boundary of said Plat A, which is also the west boundary of said Parkway;

THENCE along a curve to the right having a radius of 7592.65 feet and an arc length of 225.56 feet, being subtended by a chord of North 28 degrees 37 minutes 38

seconds West for a distance of 225.56 feet to the point of beginning. Together with and subject to covenants, easements, and restrictions of record. Said property contains 9.952 acres more or less.
