EASEMENT

Parcel No. 15-8:109:E  
 Project No. 1-15-8(6)334

Gordan G. Howes & Thelma N. Howes, his wife, Grantors,  
 of Roy, County of Davis, State of Utah,  
 hereby grant and convey to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of  
 Six Hundred and no/100ths Dollars,

an easement upon part of an entire tract of property in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section  
 24, T. 5 N., R. 2 W., S.L.B.&M. in Weber County, Utah, for the purpose of  
 constructing thereon an irrigation facility and appurtenant parts thereof  
 incident to the construction of a freeway known as Project No. 15-8.

Said part of an entire tract is a parcel of land 10.0 ft. wide adjoining  
 westerly the following described portion of the westerly side line of said  
 project:

Beginning on the south boundary line of said entire tract at a point 150.0  
 ft. perpendicularly distant westerly from the center line of said project,  
 which point is 556.25 ft. north and approximately 253 ft. east from the W $\frac{1}{4}$   
 corner of said Section 24; thence N. 10°42' E. 76 ft., more or less, to the  
 north boundary line of said entire tract.

The above described parcel of land contains 0.02 acre, more or less.

After said irrigation facility is constructed on the above described  
 part of an entire tract at the expense of said State Road Commission, said  
 State Road Commission is thereafter relieved of any further claim or demand  
 for costs, damages or maintenance charges which may accrue against said  
 irrigation facility and appurtenant parts thereof.

ALSO:

A temporary work easement to facilitate the construction of said irrigation  
 facility and appurtenant parts thereof, being a parcel of land 10.0 ft. wide  
 adjoining westerly the westerly side line of the above described easement,  
 containing 0.02 acre, more or less.

The above described temporary work easement shall expire upon completion  
 of said construction.
