

Right Of Way Deed

Edwin Howes and Lavinia H. Howes grantor.S.
of Ray County of Weber State of Utah,
hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the
sum of Three and 00/100 DOLLARS,
the following described right of way across the grantor..... land in Weber County,
State of Utah, as follows:

Right of way for highway known as F. A. Project No. 114-E across the grantor's
land in the E 1/4 NW 1/4 of Section 24, T. 5 N., R. 2 W., S. L. M. Said right of
way is contained within a parcel of land 50 feet wide, 50 feet on the east side of
the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the south boundary line produced of said
grantor's land and said center line of survey at Engineer's Station 397+97.6,
which point is 223.6 feet north along the west line of said Section 24, from the
west 1/4 corner of said Section 24; thence N.0°10'E., 545.4 feet (542.65 feet
County Records) to the intersection of said center line of survey at Engineer's
Station 403+43 and the north boundary line produced of said grantor's land, which
point is 769 feet north along the west line of said Section 24, from the west 1/4
corner of said Section 24, as shown on the official map of said project on file in
the office of the State Road Commission of Utah. Above described parcel of land
contains 0.63 acre, of which 0.41 acre is now occupied by the existing highway.
Balance 0.22 acre.

In executing this deed, the grantor hereby grants to the State Road Commis-
sion of Utah permission to relocate and reconstruct within the grantor's land and
outside the limits of above described right of way, all irrigation ditches exist-
ing within said limits of above described right of way, and to extend onto said
grantor's land and outside the limits of above described right of way all cut
and/or fill slopes made necessary by the grading for sidewalks on said project.

The purpose of this deed is to grant a perpetual right of way for highway purposes.
