CONSENT TO SUBLEASE AGREEMENT

THIS CONSENT TO SUBLEASE AGREEMENT is made this 27 day of 1995, by and between the undersigned holders of undivided interests in the lessee's interest in the "Ground Lease" as that term is defined below, and in favor of US WEST NewVector Group, Inc., ("Sublessee").

RECITALS

- A.
