

**AN ORDINANCE AMENDING THE GENERAL PLAN OF UTAH COUNTY, UTAH, TO
ADD A LARGE SCALE UTILITY LINE CORRIDOR FOR CONSTRUCTION AND
MAINTENANCE OF A 20 INCH BURIED GAS TRANSMISSION PIPELINE**

Part I:

Pursuant to Section 17-27a-403 and 17-27a-404 of the Utah Code Annotated, 1953, as amended, the General Plan for Utah County is hereby amended to designate a large scale utility line corridor from the intersection of county roads 8730 West and 8170 North, Lehi, to the Lake Side Power Plant site, Vineyard, through Sections 17, 20, 21, 26, 27, 31 and 36, T5S, R1E, Salt Lake Base and Meridian. The location of the pipeline is more particularly described on Exhibit "A", attached hereto and incorporated herein by this reference.

Part II:

This amendment to the Utah County General Plan establishes a large scale utility line corridor that allows the construction of a 20 inch buried gas transmission pipeline.

Part III:

A title page which bears the enactment date of this ordinance, is hereby ordered to be filed in the three copies of the Utah County General Plan which is filed with the Utah County Clerk-Auditor.

Part IV:

If any of the sections, sentences, clause or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdictions, such shall not affect or invalidate the remaining portion contained here.

Part V:

This ordinance shall become effective fifteen (15) days after its passage, and upon at least one (1) publication in a newspaper published in and having general circulation in Utah County.

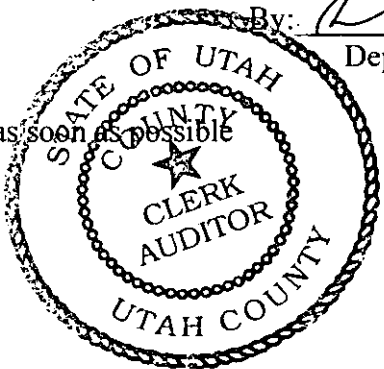
