DEED OF EASEMENT

FORREST WATERS AND EDA WATERS, Husband and Wife
of CGDEN, County of WEBER, State of UTAH, hereinafter
referred to as Grantor, hereby conveys to THE UNITED STATES OF AMERICA,
acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat.,
388) and acts amendatory thereof or supplementary thereto, Grantee, for
the sum of One Dollar (\$1.00), a perpetual easement to construct, re-
construct, operate and maintain an underground pipeline or pipelines and
appurtenant structures which latter may protrude above the ground on,
over or across the following described property in Weber County, State
of Utah:

A tract of land in the Southwest Quarter of the Northwest
Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Fifteen (15), Township Five (5)
North, Range One (1) West, Salt Lake Base and Meridian,
being more particularly described as follows:

Beginning at a point on the centerline of what is known as
the Uintah Bench Lateral 4.1L-0.1L at Station 15+35.0, a
point on the Northeast corner of the Grantor's property,
from which point the Northwest corner of said Section 15
bears North 35°48' West Twenty-two Hundred Ninety-one and
Nine-tenths (2291.9) feet, and running thence South 0°06'
West along the Easterly line of the Grantor's property Five
Hundred Fifty-seven (557.0) feet to the Southeast corner of
the Grantor's property; thence West Ten (10.0) feet; thence
North 0°06' East Five Hundred Fifty-seven (557.0) feet to the
North line of the Grantor's property; thence East Ten (10.0)
feet to the point of beginning, containing 0.13 of an acre,
more or less.
