
- (1)(a) the owner entered into a written contract with an original contractor, a factory built housing retailer, or a real estate developer;

- (3) An owner who can establish compliance with either section (1) or (2) may perfect the owner's protection by applying for a Certificate of Compliance with the Division of Occupational and Professional Licensing.
