For good and valuable consideration, receipt of which is hereby acknowledged, the undersigned Property Owner Tioga Funding Real Estate group, LLC, as GRANTOR(S) hereby grant to HEBER CITY, a municipal corporation situated in Wasatch County, the State of Utah, as CITY, a temporary easement and right-of-way for accessing, constructing, operating, and maintaining 3-temporary turnaround areas in the easement granted herein. The Grantor and its successors in interest hereby relinquish the right to construct any improvement, structure, change in topography, or landscaping which would interfere with the operation, replacement or repair of the turnaround facilities constructed and maintained under the provisions of this easement, without the express written consent in advance of the CITY. Any improvements erected within this easement without written consent will be removed at the Grantors expense.

GRANTOR agrees on its own behalf, and on behalf of its successors in interest, that it will indemnify and hold harmless CITY for any damages to the property which result from maintenance and repair operations by CITY of its facilities within the easement.

It is the intent of the Grantor to construct new roads connections in the future that will eliminate the need for this turnaround easement. 
