ASSIGNMENT OF DECLARANT'S INTEREST

Gilmore, as Trustee of Trust 127 dated August 1, 2006, as to an undivided 2% interest, Lisa Vandersteen, an individual, as to an undivided 1% interest, Stephen P. Gaskill, an individual, as to an undivided 3% interest, and William G. Gaskill, an individual, as to an undivided 5% interest (collectively, the "Distributees") certain portions of the Shopping Center Land and the Distributees have in turn conveyed all of such portions of the Shopping Center Land to CCA-Tooele Town Center, LLC, a Delaware limited liability company ("CCA-Tooele"). 
