Hilda M. Adams, a widow, and Charles L. Adams, a single man, ~~husband~~ wife, Grantors, of Davis County, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and no guy anchors and 2 poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantors, in Davis County, Utah, along a line described as follows:

Beginning at a north boundary line of the Grantors' land at a point 835 feet south and 34 feet east, more or less, from the west one quarter corner of Section 17, T. 4 N., R. 1 W., S.L.M., thence S. 0° 06' E. 65 feet, more or less, to a south boundary line of said land and being in the NW 1/4 of the SW 1/4 of said Section 17.

Also, beginning at a south boundary line of the Grantors' land at a point 695 feet south and 34 feet east, more or less, from the west one quarter corner of Section 17, T. 4 N., R. 1 W., S.L.M., thence N. 0° 06' W. 74 feet, more or less, to a north boundary line of said land and being in the NW 1/4 of the SW 1/4 of said Section 17.

Beginning at the south boundary line of the Grantors' land at a point 835 feet south and 34 feet east, more or less, from the west one quarter corner of Section 17, T. 4 N., R. 1 W., S.L.M., thence N. 0° 06' W. 65 feet, more or less, to the north boundary line of said land and being in the NW 1/4 of the SW 1/4 of said Section 17.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
