SUBJECT TO taxes and assessments not yet due and payable, and those certain permitted exceptions described on Exhibit B attached hereto and incorporated by reference herein.

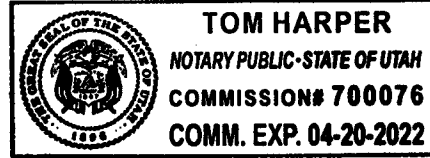
