Texas Gulf Sulphur Company, a corporation doing business in the State of Utah, Grantor, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns and licensees, Grantee, for the sum of One (\$1 0) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution, and telephone circuits of the Grantee, and seven guy anchors, 38 poles and one two-pole structure, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained on, under, upon and across the premises of the Grantor, in Grand County, Utah along a line described as follows:

Beginning at the North boundary line of the Grantor's land at a point 715 feet South and 35 feet West, more or less, from the Northeast corner of Section 3, T. 25 S., R. 20 E., S.L.M., thence S. 0° 12' E. 4260 feet, more or less, thence N. 89° 34' E. 1338 feet to the East boundary fence of said land and being in Lots 1, 8, 9, 16 and the NE 1/4 of the SE 1/4 of said Section 3 and the NW 1/4 of the SW 1/4 of said Section 2, Township and Range aforesaid.
