RIGHT OF WAY EASEMENT

A right of way over the east 26 feet of that certain property conveyed by Quit Claim Deed and recorded as Entry No. 7812345 in Book 8421 at Pages 1260 and 1261 of the Official Records of the Salt Lake County Recorder. The east line of said right of way being coincident with the west line of 900 West Street. The above said right of way contains 1351 square feet or 0.031 acre.

Together with the right of access to the right of way from adjacent lands of Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefor) the future right to keep the right of way and adjacent lands clear of all brush, trees, timber, structures, buildings and other hazards which might endanger Grantee's facilities or impede Grantee's activities.

At no time shall Grantor place, use or permit any equipment or material of any kind that exceeds twelve (12) feet in height, light any fires, place or store any flammable materials (other than agricultural crops), on or within the boundaries of the right of way. Subject to the foregoing limitations, the surface of the right of way may be used for agricultural crops and other purposes not inconsistent, as determined by Grantee, with the purposes for which this easement has been granted.


