### PARKING AGREEMENT

This Parking Agreement is entered into and granted this <u>29</u> day of February, 2012, by and among SNC Properties LLC, a Utah limited liability company ("SNC"), All American Leasing, LLC, a Utah limited liability company ("AAL"), and Interwest Condominium Association, Inc. ("Interwest"), jointly "Parties."

#### Recitals

The Parties are the owners of contiguous real property located on Pennsylvania Avenue in Ogden, Utah.

SNC is the owner of the real property located at 2930 Pennsylvania Avenue, Ogden, Utah 84401, more particularly described on Exhibit "A" attached hereto and by this reference incorporated herein.

AAL is the owner of the real property located at 2924 Pennsylvania Avenue, Ogden, Utah 84401, more particularly described on Exhibit "B" attached hereto and by this reference incorporated herein.

Interwest is the owner association of the owners of the real property located at 2928 Pennsylvania Avenue, Ogden, Utah 84401, more particularly described on Exhibit "C" attached hereto and by this reference incorporated herein.

The parties desire to allow SNC to use a portion of the property belonging to AAL and the Interwest for parking on the south side of the SNC property.

### Parking License

1. Parking License. AAL and Interwest, for themselves, their assigns and legal representatives, hereby grant to SNC, for the benefit of SNC, its tenants and their employees and invitees, an irrevocable non-exclusive license for the purpose of parking on that portion of property belonging to AAL and Interwest which lies within twenty (20) feet of the south wall of the south building belonging to SNC. SNC shall not use for parking the property belonging to AAL and Interwest which lies between twenty (20) feet of the south wall of the south building belonging to SNC and the south property line of the property belonging to R & J and Interest. This license shall include the right of ingress and egress to and from SNC's property over the property belonging to AAL and Interwest which is not used for parking,

which has been historically used by SNC, allowing one way traffic around SNC's south building. This Agreement shall remain in force until terminated by agreement of the parties, their successors or assigns.

### Miscellaneous Provisions.

- (a) This Agreement shall be binding on and shall inure to the benefit of the respective parties, their successors, permitted assigns, personal representatives, and heirs.
- (b) The headings used in this Agreement are inserted for reference only and shall not be deemed to limit or affect in any way the meaning or interpretation of any of the terms or provisions of this Agreement.
- (c) This Agreement constitutes the entire understanding and agreement of the parties and supersedes all prior agreements, representations, or understandings between them relating to the subject matter hereof.
- (d) The provisions of this Agreement are several and should any provision hereof be void, unenforceable, or invalid, such void, unenforceable, or invalid provision shall not affect any other provision of this Agreement.
- (e) Any waiver by either party hereto of any breach of any kind or character whatsoever by the other party, whether such waiver be direct or implied, shall not be construed as a continuing waiver or a consent to any subsequent breach of this Agreement on the part of the other party.
- (f) This Agreement shall not be modified except by an instrument in writing signed by the parties hereto.
  - (g) Time is of the essence of this Agreement.
- (h) This Agreement shall be interpreted, construed, and enforced according to the laws of the State of Utah.
- (i) The parties agree that in the event any arbitration, action or court proceeding is brought by any party to enforce the obligations under this Agreement, the prevailing party shall be entitled to recover reasonable attorney's fees, together with court and collection costs, including but not limited to those fees and costs incident to any action or participation in or in connection with a case or proceeding under any applicable chapter of the Bankruptcy Code or any successor statute thereto.

- (j) The parties hereby agree to execute and deliver such additional documents and to take such further action as may become necessary or desirable to fully carry out the provisions and intent of this Agreement.
- (k) All notices, demands, and requests required or permitted to be given hereunder shall be deemed given if delivered or if mailed by registered or certified mail, postage prepaid, addressed to the following:
