EASEMENT

THIS INDENTURE, made as of this 28 day of April, 1941 between SOUTH JORDAN CANAL COMPANY, a corporation of the State of Utah, GEORGE W. LAST and Vera LAST, his wife, JAMES R. STEALMAN and Lavour STRAIMAN, his wife, WILLIAM H. STRAIMAN and Rachel a STRAIMAN, his wife, CHARLES M. EVANS, Administrator of the Estate of M. R. Evans, HAZEL WOOD, THOMAS W. JONES, WILLIAM JONES, WILLARD MARGETTS, ALICE MARGETTS, GLADYS MARGETTS, RAY R. JONES, LOLA FAURSCHOU, VERA JONES, KRNNETH JONES, LESLIE JONES, IVAN JONES, IVY BECKSTEAD and MELVIN JONES, only heirs at law of HENRY T. JONES, THOMAS W. and LILLIAN M. JONES, husband and wife, JOHN T. HOOTH and Selene May BOOTH, his wife, LOLA H. FAURSCHOU, VERA JONES, KENNETH JONES and JONES, his wife, KLMER R. MARGETTS and Caroline MARGETTS, his wife, CLARA SILCOX, ROSEZELLA DETOMASE, LOUKILA FOSE, only heirs at law of JOHN and ESTHER STRADMAN, all of Salt Lake County, State of Utah, and OLSON BROTHERS COMPANY, a corporation, Grantors, and WEST SIDE WATER SYSTEM, a corporation of the State of Utah, Grantee;

## WITNESSETH:

That the said Grantors for and in consideration of the sum of Ten (\$10.00) Pollars and other good and valuable considerations, receipt whereof is acknowledged, have granted, bargeined and sold, and do hereby grant, bargain and sell unto said West Side Water System, its successors and assigns, an easement and right of way for a culinary water pipeline along and adjacent to the North bank of the South Jordan Canal in the Southwest quarter of Section 22, Township 2 South, Range I West, S. L. B. & M., and along and adjacent to the West bank of said canal in the Southeast quarter of Section 21, and the East half of Section 28 of said township and range in Salt Lake County, State of Utah; said easement to cover the right of said West Side Water System to maintain, repair or replace said water line in its

present position, which position it is impracticable to locate accurately on the ground for the reason that it was installed in the year 1917 without survey, but it was so installed adjacent to the said North and West banks, respectively, of the South Jordan Canal, the center line of which is described in deeds held by the South Jordan Canal Company as follows:

Beginning at the center of 1700 West Street at a point 19 rods South of the Northeast Corner of the Southwest quarter of Section 22, Township 2 South, Range 1 West, Salt Lake Base and Meridian, and running in a Southwesterly direction 170 rods to the center of 2200 West Street at a point 67.3 rods South of the Northwest corner of the Southwest quarter, said Section 22; thence in a Southwesterly and Southerly direction 44 roos to the center of 7000 South Street at a point 24 rods West of the Southeast corner of Section 21, Township 2 South, Range 1 West, Salt Lake Base and Meridian; thence continuing Southerly 161.7 rods to a point 7.2 rods West of the Northeast corner of the Southeast quarter of Section 28 of aforesaid township and range; thence Southerly 91 rods to a point 2 rods West and 90 rods South of said Northeast corner of the Southeast quarter of Section 28.

Because said pipeline may be on the canal right of way, or it may at times be on adjacent privately owned property, both the said South Jordan Canal Company and all adjacent property owners have joined in a grant of this easement.

TO HAVE AND TO HOLD the same unto the West Side Water System, its successors and assigns so long as such pipeline shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate and replace the said pipeline; and Grantee by acceptance of this easement agrees to compensate Grantors, or any of them, for any damages done to lands or crops of said Grantors caused by Grantee in the maintenance, repair, replacement or operation of said pipeline.

IN WITNESS WHEREOF, the corporate Granters have caused this instrument to be executed by their proper officers respectively, and Charles M. Evans, Administrator of the Estate of M. R. Evans, deceased, has executed same, pursuant to the order of the Probate Court having jurisdiction of said Estate, and the individual Granters have hereunto set their hands as of the day, and vehicling above written.
