RIGHT OF WAY DEED

Charles Cunningham, James W. Cunningham and Wanda W. Cunningham, his wife grantor of Petersboro, County of Cache State of Utah, hereby grant, bargain, and sell to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Eleven Hundred CC/lOC DOLLARS, the following described right of way across the grantor's land in Cache County, State of Utah, as follows:

Right of way for highway known as F. A. Project No. 154-C across the grantor's land in the N-1/2 SE-1/4 and SW-1/4 NE-1/4 of Section 29, T. 12 N., R. 1 W., S.L.B.&M. Said right of way is a trip of land 100 ft. wide, 50 ft. on each side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the east line of said Section 29 and said center line of survey at Engineer's Station 376;69.8, which point is 646.0 ft. southerly along said east section line from the east 1/4 corner of said Section 29; thence N. 72°16' W., 2809.0 feet to the intersection of said center line of survey at Engineer's Station 404;78.8 and the west line of said NE-1/4 of Section 29, which point is 646.0 ft. southerly along said east section line and and 2809.0 ft. N. 72°16' W. along said center line of survey, from said east 1/4 corner of Section 29, as shown on the official map of said project on file in the office of the State Read Commission of Utah.
