

**AMENDMENT TO FOURTH SUPPLEMENTAL DECLARATION**

WHEREAS, the Declarant desires to amend the Fourth Supplement and is executing this Amendment for such purpose.

NOW THEREFORE, the Declarant hereby amends the Fourth Supplement as follows:

1. Legal Description. Exhibit A attached to the Fourth Supplement is hereby amended, superseded and replaced by Exhibit A attached hereto and made a part hereof.
2. Fourth Supplement Remains in Effect. Except as amended hereby, the Fourth Supplement shall continue unmodified and in full force and effect.

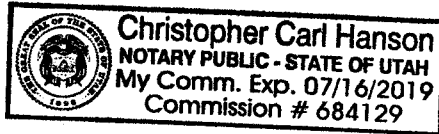

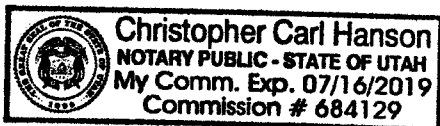
